



## **MONARCH'S ADULT SEASONAL PROGRAMS**

Monarch's adult seasonal programs are offered as a four week session. You can sign up for the whole program and take advantage of the progression that comes from weekly clinics or you can simply sign up for individual days. Each program is designed for a specific population and will help you achieve a high level of proficiency in the discipline of your choice.

Below is the registration information for the programs. Please select all the programs you would like to register for and mark the appropriate boxes. Please see attached ability level sheet to help you make an accurate assessment of your ability level. This information is needed for Monarch's planning purposes and class assignment will be made on the first day after meeting with instructors.

### **POLICIES:**

*Refunds:* Monarch does not offer refunds or make-ups for missed program days. If a student does miss a program day for any reason they will be eligible for a half price two hour private.

*Weather:* There are no make-up days for bad weather, including snow, cold or wind. Severe winter weather is a likely possibility on all program days. Please plan accordingly and make decisions best for your family's situation. For tips on proper winter dressing please see the information below.

### **WHAT TO EXPECT and PROGRAM INFORMATION**

*First day:*

- Please meet Monarch's staff in the Lesson Meeting Area located north of the Lesson and Rental Center. Groups will be formed near the black butterfly sign.
- Arrive at 1:35pm. Programs will begin at 1:45pm sharp.
- Participants must be dressed and ready to ski
- Participants should take care of personal needs before program begins
- Program ends at 3:30pm.

We want our programs to be fun, with no pressure, and reasonable expectations. We will do our best to meet the individual needs of each participant and group them in the appropriate classes based on ability. *What to wear:*

The participant should wear warm layers of clothing under a waterproof jacket and pants. Warm waterproof mittens or glove, a warm hat and one pair of warm socks is recommended. Wool or synthetic clothing is preferable to cotton garments as cotton absorbs water and does not hold body heat. Goggles and a helmet are also strongly recommended.

*Equipment:*

Monarch does not supply snow riding equipment for the participants. Each participant should arrive at the program with appropriate, modern equipment that has been sized and adjusted by a professional, specific to the participant's specifications.

**Ability Level Chart:**

<b><u>1</u></b>	It is my first day. I have no previous experience in this snow sport.
<b><u>2</u></b>	I'm learning to turn and stop. I'm ready to try the chairlift.
<b><u>3</u></b>	I can stop with confidence and turn both ways. I'm comfortable riding the chairlift. I'm ready to leave the beginner hill and explore more green runs.
<b><u>4/5</u></b>	I'm comfortable on green runs. I can link turns and stop with confidence. I'm ready to explore blue terrain.
<b><u>6/7</u></b>	I can control my speed and feel rhythm in my turns on blue terrain. I'm ready to try groomed black runs. I want to try some easy bumps.
<b><u>8/9</u></b>	I'm confident on groomed black runs and I'm ready to explore tactics for moguls, different snow conditions and steep runs.

**SKI SCHOOL WARNING, ASSUMPTION OF RISK, RELEASE OF LIABILITY & INDEMNIFICATION  
AGREEMENT**

**PLEASE READ CAREFULLY BEFORE SIGNING. THIS IS A RELEASE OF LIABILITY & WAIVER OF CERTAIN LEGAL RIGHTS.**

1. The person who is participating in Ski School and or Children's Center programs shall be referred to hereinafter as "Student". The "Undersigned" means only the Student when the Student is age 18 or older OR it means both the Student and the Student's parent or legal guardian when the Student is under the age of 18. The Undersigned agree and understand that taking part in ski school, skiing, snowboarding and using ski area facilities, including the lifts, for any purpose including childcare (hereinafter the "Activity"), can be **HAZARDOUS AND INVOLVES THE RISK OF PHYSICAL INJURY AND/OR DEATH.**

2. The Undersigned are advised that a person using any of the facilities of the ski area is considered a skier. The Undersigned acknowledge and understand the dangers and risks of skiing and understand that the Student, as a "skier" under Colorado law, **ASSUMES ALL INHERENT DANGERS AND RISKS** as provided by the Colorado Ski Safety Act (hereinafter "Act").

3. The Undersigned further understand and agree that in signing this Agreement, the Undersigned are expressly **acknowledging and assuming additional risks and dangers that may result in property damage, physical injury and/or death above and beyond those outlined in the Act, including but not limited to:**

Falling; drills; exercises; free skiing; following the direction of the instructor; terrain selection of the instructor; avalanches; cornices; suffocation; crevasses; equipment failure; equipment malfunction; equipment damage; Student's improper use of equipment; Student's use of his/her own personal equipment; interaction with other students; snow play, taking field trips by walking or by use of ski area or public transportation; playing, eating and/or sleeping in a childcare environment; Student's failure to maintain or otherwise upkeep his/her own personal equipment; slick or uneven surfaces; slipping; tripping; loss of balance; rugged mountainous terrain; bumps; tree wells; downed timber; rocks of various sizes; holes; debris; marked and unmarked obstacles; drainage channels; varying visibility; unmaintained trails; path and/or trail obstructions; unmarked roads and/or trails; Student or another acting in a negligent manner that may cause and/or contribute to injury to Student or others, such as selecting terrain that exceeds his/her ability and not acting within such ability; Student's failure to comply with signage; collisions with natural or man-made objects or collisions with other people; falling objects; encounters with snowmobiles and/or other motor vehicles; becoming lost or separated; lack of shelter; lift loading, unloading, and riding; storms, lightning, hail, snow and other adverse weather; limited access to and/or delay of medical attention; Student's health condition; strenuous activity; fatigue; exhaustion; dehydration; hypothermia; high elevation; altitude sickness; frostbite; & mental distress from exposure to any of the above.

4. Pursuant to Colorado law, Student assumes the responsibility of maintaining control at all times while engaging in the Activity. Student is responsible for reading, understanding and complying with all signage, including instructions on use of lifts. Student must have the physical dexterity and knowledge to safely load, ride and unload the lifts. Student assumes the risks of riding the lifts and engaging in activities accessible from the lifts. Further, the Undersigned understand that a minor Student may use the ski lifts without an adult present. The Undersigned are advised that snowmobiles, snowmaking, and snow-grooming equipment may be encountered at any time, and the Undersigned recognize that falls and collisions occur and injuries are a common and ordinary occurrence of the Activity.

5. The Undersigned acknowledge and understand that the description of the risks listed above are not complete and that participating in the Activity, whether or not described, may be dangerous and may also include risks which are inherent and/or which cannot be reasonably avoided without changing the nature of the Activity. By signing this document, the Undersigned recognize that property loss, injury, serious injury and death are all possible while participating in the Activity. **RECOGNIZING THE RISKS AND DANGERS, THE UNDERSIGNED UNDERSTAND THE NATURE OF THE ACTIVITY AND VOLUNTARILY CHOOSE FOR STUDENT TO PARTICIPATE IN AND EXPRESSLY ASSUME ALL RISKS AND DANGERS OF THE ACTIVITY, WHETHER OR NOT DESCRIBED ABOVE, KNOWN OR UNKNOWN, INHERENT OR OTHERWISE.**

6. Additionally, in consideration for allowing the Student to participate in the Activity, **THE UNDERSIGNED HEREBY AGREE NOT TO SUE** PowderMonarch LLC, or any of their respective successors in interest, affiliated organizations and companies, insurance carriers, agents, employees, representatives, assignees, officers, directors, and shareholders (each hereinafter a "Released Party") for any property damage (including but not limited to equipment damage), injury or loss to Student, including death, which Student may suffer, arising in whole or in part out of Student's participation in the Activity. By agreeing not to sue,

the Undersigned are releasing any right to make a claim or file a lawsuit against any Released Party. Also, the **UNDERSIGNED AGREE TO HOLD HARMLESS AND RELEASE EACH AND EVERY RELEASED PARTY FROM ANY AND ALL LIABILITY** and/or claims for injury or death to persons or damage to property arising from Student's participation in the Activity, including, but not limited to, those claims based on any Released Party's alleged or actual **NEGLIGENCE or BREACH of any CONTRACT** and/or express or implied **WARRANTY**.

7. By execution of this Agreement, the Undersigned also **AGREE TO DEFEND AND INDEMNIFY/REIMBURSE** each Released Party from any and all claims of the Undersigned and/or a third party arising in whole or in part from Student's participation in the Activity.

8. In consideration for allowing Student to participate in the Activity, the Undersigned **AGREE THAT ANY AND ALL CLAIMS** for injury and/or death arising from the Student's participation in the Activity shall be **GOVERNED BY COLORADO LAW** and **EXCLUSIVE JURISDICTION** of any claim shall be the **DISTRICT COURT OF CHAFFEE COUNTY, COLORADO** or in the **FEDERAL COURT FOR THE STATE OF COLORADO**.

**Monarch Mountain recommends the use of helmets while participating in the ACTIVITY. THE UNDERSIGNED understand and agree that a helmet IS IN NO WAY A GUARANTEE OF SAFETY and that no helmet can protect the wearer against all foreseeable impacts to the head, and that skiing and snowboarding and other related activities can expose the user to forces that exceed the limits of protection provided by this helmet. THE UNDERSIGNED also understand that the helmet does not guard against injury to the neck, spine or any other part of my body, and that these limitations are INHERENT RISKS of the ACTIVITY.**

9. In the case of a minor Student, the Undersigned parent or legal guardian acknowledges that he/she is not only signing this Agreement on his/her behalf, but that he/she is also signing on behalf of the minor and that the minor shall be bound by all the terms of this Agreement. Additionally, by signing this Agreement as the parent or legal guardian of a minor Student, the parent or legal guardian understands that he/she is also waiving certain rights on behalf of the minor that the minor otherwise may have. The undersigned parent or legal guardian agrees that but for the foregoing, the minor Student would not be permitted to participate in the Activity.

10. By signing this Agreement without a parent or legal guardian's signature, Student, under penalty of fraud, represents that he/she is at least 18 years of age. If signing as the parent or guardian of a minor Student, signing adults represent that they are a legal parent or guardian of the minor Student.

11. The Undersigned understand and acknowledge that this Agreement is a contract and shall be binding to the fullest extent permitted by law. If any part of this Agreement is deemed to be unenforceable, the remaining terms shall be an enforceable contract between the parties. It is the Undersigned's intent that this Agreement shall be binding upon the assignees, subrogors, distributors, heirs, next of kin, executors and personal representatives of the Undersigned.
